Comm exercise on 2/9 – tri-county and beyond. Drive by Cal-Em – attemtp to contact Sacto early warning system.

In a group – 1978 – in high school got license. In grade school had CB. Quick history of equipment and experience.

Mobile Comm Center – hand out. County wide resource, in coordination with UPD and Ukiah Valley Fire, Sheriff, UFD – Govt. Law Enforcement and Public Safety. Discussed equipment and basic need/operation. Has been called out on some SAR, shootings, fires, etc. Move communication out to location is intent – optimize outcome, rapid response.

Will set up @ 2/9 exercise. Will have UPD, Fire, school net, Willits PD, White 1, CHP, back up, Humboldt, CalTRans, Eureka, Howard Forest, MedNets, Howard MH, Coast H, Lake County, Sonoma County, etc. Air card will be up and running, BGAN – make sure it works, deploy cell

Maintenance and costs of upkeep is shared and mostly grant funded (lots of FEMA).

Microwave – backup is control stations talking to repeater sites. VHF – CESRS, OES fire – has a CAHTO site. Did a drill @ Branscomb. 156.045 (?) splinter channels. 15 kHz increments/spacing. Squeezed in another channel @ 7.5 spacing. Deviation – either 2.5 or 3. (Narrow banded).

(Dan KNOWS his stuff!)

Some cities have scrapped digital and gone back to analog as ambient noise does not translate to ones and zeros.

Handout – fire and EMS repeater list. Some are linked through the county microwave system, some are stand alone. Designed to activate pagers.

Dispatch centers – contract with CalFire. Willits and UPD dispatches also. CalStar went to their own dispatch. CalComm. Reach is a call center. I don't understand the last two statements.

Citizens have scanners – they will not have to change from wide band to narrow band - they will have to turn up their machines – Fx did not change – just more compacted.
