#### Other McARCS news and discussion

- North Coast Simplex net revision energy
  - Recently there's been a lot of interest among net participants in making the net more active and resilient in emergency situations.
  - Experimentations with different formats, methods, and bands.

- McARCS Net Coordinator
  - o Nick KI6RIT has been practicing filling in John W6FQX's net log spreadsheet
  - John recently posted an updated version of the countywide net control script.
- US Forest Service proposed fees
  - The US Forest Service is proposing to implement a statutorily required annual fee for new and existing communications use authorizations to cover the costs of administering its authorization program.
  - The Forest Service proposal results from requirements set forth in the Agriculture Improvement Act of 2018.
  - o Anthony Peak repeater (eastern Round Valley) is on USFS land.
  - Currently the repeater owner is paying \$100/year to have equipment at the site.
  - With the new fees, that cost will go up to \$1400/year, which is prohibitively expensive.
     This is even with the repeater equipment running entirely on solar and battery power.
